Artist Patrick Gracewood's sculpture, A Visit to Grandmother's House, (attached) is one of those pieces, now still in progress. The figure's historic touch points to the community's large influx of German speaking immigrants during the second half of the 19th century and roadside shrines common to that part of Europe at the time-- together with the more universally shared experiences of going home-- finding shelter or nurture in persons or place. The Interurban trolley (1893-1956), after all, was one of the paths by which people in this community found their way 'home' (or to grandmother's house) for a long, long time--Patrick invites members of the community (past or present) to submit recollections/tributes to special people/places in which or whom they have found 'home'. Please limit them to paragraph or page. These will be placed in a secured compartment of the sculpture to live there for the life of the piece.
