1. ZO235-17-D 3260 Oak Grove Blvd - Oak Grove Storage

Type: Design Review - OGCC has appealed this development at the hearing on Aug. 10th.

Status: Hearings Officer decision pending.

There was considerable discussion about the negative impact this facility might have on the Oak Grove community but it appears the existing zoning allows such a structure.

Status: Approved (Extended to Nov. 1, 2019)

 ZO361-17 - 14928 SE Oatfield Rd, Demolition of Historic Philip Oatfield House - Application reapplied -

Status: Hearings Officer Decision pending

4. PD 2017-001 (Milwaukie) Turning Point Church property 13333 SE Rusk Road, 92 dwelling planned development. OGCC expressed concerns.

Status: Approved by Planning Commission. City council hearing is Sept 5, 6:30 pm

ZO426-17 15314 SE Rupert Dr - 4-10 Lot Subdivision "Berry Meadows" OGCC: Response due 9/5

There was considerable discussion about this application among the membership. A shared concern regarding the wide range of 4-10 dwellings was discussed.

- ZO449-17 6420 SE Mabel Ave Steep slope review, SFH in HCA.
  OGCC: Response due 9/6. Note. Presenters suggested the lot
  is "not buildable" due to the steep slope.
