- 6:50 **Review Mar. Apr 25 mtg. What worked well?** What improvements could have been made?
 - Local Business Raw Oregon Honey; Steve Vollintine All agreed this presentation was very interesting and well received. Generated lots of member questions.
 - **Fire District** Mike especially like this presentation. Special interest/concern regarding refilling expired fire extinguishers: if device is metal, can refill but Fire Dept suggests just as cost effective to buy new. Is this an environmental conundrum?

Baldwin noted 2 questions **Deputy Chief Coreless** couldn't answer so Fire Dept suggested to Baldwin, via email, a return visit to OGCC to answer. Baldwin responded suggesting an email with answers would suffice but they are welcome to present the answers in person.

- **Code Enforcement** - Many felt the speaker was reading from notes too fast. There was general discussion about how citizens can make a complaint by going online. Filing a complaint is quick & easy and apparently, effective. Generally a minimum of 2 confidential complaints is recommended.

What role should OGCC take in advising membership of code enforcement effectiveness?
