1. Review July 22nd meeting:

Valerie thanked Greg for being so helpful with the technology during the Zoom meeting discussion about racism and white privilege. A majority of the people didn't say anything. Any feedback from people who didn't speak would be good to find out, especially the commissioners.

Joseph: If we do it again, it gets easier for more people to feel comfortable participating. It can be part of community engagement, bringing in more members; continuing to move through it as a curriculum almost.

The Jennings Lodge CPO put together a statement that they sent to the county, affirming the county's statement in favor of inclusion. They got buy-in from the community first. Might be a nice way to follow-up from our last meeting. If we don't have people who want to do that, then the statement could come from the board.

Jane suggested it might be good to hammer something out first, then present it at our next meeting.

Jan volunteered to follow up with Paul Savas about the racist clauses in property deeds and the possibility of asking people to pay to have it changed, then having the county set all or a portion of the funds aside for a minority affordable housing fund.

MOTION: Valerie **MOVED** that the board empower Jan to move forward in researching changing property deeds to remove racist covenants and using the funds for minority affordable housing. Jane seconded. It **passed unanimously**.

- 3. CPO Summit Jim reported that the CPOs said they are not hearing back in a timely fashion when they send correspondence to the county. The county says it's supposed to be posted within four days. Katie Wilson will put info from us out on Next Door. They're finding out if we they can use the county's Zoom account for meetings. If they record the meetings, the county said it can replace the minutes.

There's a need for a new location for the Oregon City transfer station. The current site is inadequate, but there's no available land that's large enough. They're looking around Clackamas County for a large piece of land. Luckily, it's not going to be very close to us. It's a dump for paint, chemicals, wood, metal, other garbage.

I-205 tolling – only voting members are going to have input – the cities. We only have one person on the C4 council. What's the impact on Oak Grove? There will be impact on McLoughlin, for sure. There's no decision on where they're going to place the tolls.

In 2016, all the CPOs got together and listed 43 concerns they have. Didn't rank them. A lot of them have nothing to do with us, more about rural areas. They want to know, do we have any concerns in addition to the ones submitted in 2016? Martin is doing a really good job representing the unincorporated area.
